BYLAW NO 8/11

A BYLAW TO AMEND BYLAW NO. 5/84 BEING A BYLAW TO REGULATE THE OPERATION OF THE PARKING OF VEHICLES AND THE USE OF THE PUBLIC HIGHWAYS

The Council of the Town of Hanley in the Province of Saskatchewan enacts as follows:

1. Clause 3(j)(1) Shall be amended to read:

No person shall operate a vehicle or a combination of vehicles when the combined gross weight of the vehicle(s) with or without a load exceeds 8,000 kg on or over the public highways as listed in Appendix 8.

2. Clause 3(j)(3) reading subsections (1) and (2) shall not apply to vehicles making delivery on any highway in the municipality, shall be amended to read:

(3) Subsections (1) and (2) shall not apply to the Saskatchewan Transportation Company vehicles.

3. That Appendix 1 of Bylaw No. 5/84 be amended to read:
