A BYLAW TO AMEND BYLAW 3/13 KNOWN AS THE ZONING BYLAW

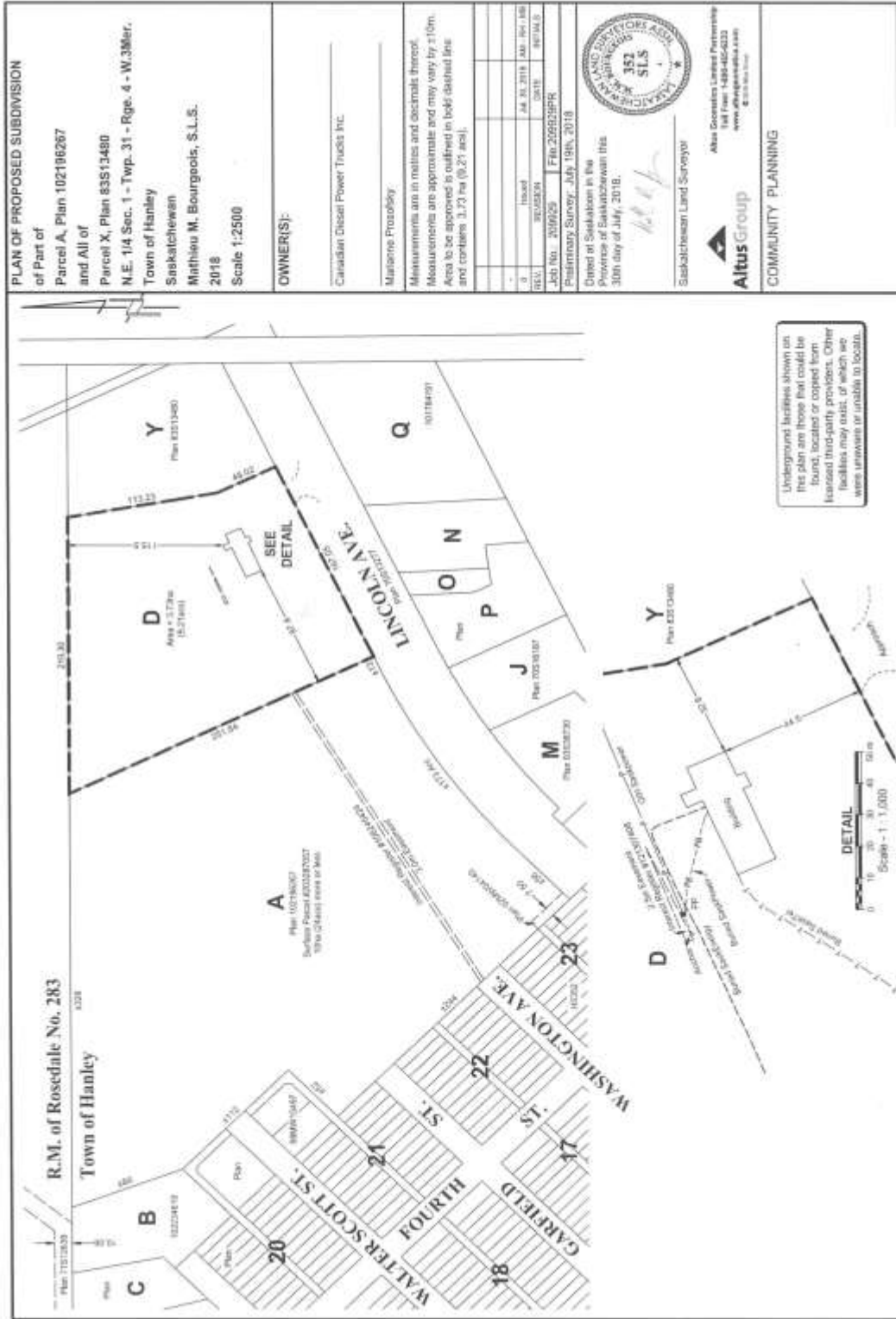
The Council of the Town of Hanley in the Province of Saskatchewan enacts to amend Bylaw No.3/13 as follows:

1. Part 8.2 ZONING DISTRICT MAP be amended to reflect rezoning Parcel D, as per the Plan of Proposed Subdivision drafted by Mr. Mathieu Bourgeois, S.L.S. of Altus Geomatics, dated September 6, 2018, which is attached as Appendix A and forms part of this bylaw, to C2 Highway Commercial from Future Urban Development- FUD.
2. Part 8.2 ZONING DISTRICT MAP is amended to replace the Zoning District map with the updated map attached as Appendix B and forms part of this bylaw.
3. This Bylaw comes into force and effect on the date of final approval of Bylaw 12/18, being a bylaw to amend the WaterWolf Growth Management Plan (District Plan), by the Minister of Government Relations.
