

**TOWN OF HANLEY**

**BYLAW NO. 9/2018**

**A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE RM OF ROSEDALE NO. 283 RESPECTING THE FUNDING OF THE SKATING RINK.**

The Council of the Town of Hanley, in the Province of Saskatchewan enacts as follows:

1. The Town of Hanley is hereby authorized to enter into the agreement, attached hereto and forming part of this bylaw, and identified as Exhibit A, with the RM of Rosedale No. 283 for the purpose stated within the agreement.
2. The Mayor and Administrator of the Town of Hanley are hereby authorized to sign and execute the attached agreement identified as Exhibit A.
3. This bylaw shall come into force and take effect from and after the day of final passing thereof.

This agreement Witnesses as follows:

1. The parties to this agreement agree to the financial contribution provided by the Rural Municipality of Rosedale no. 283 towards the cost of operating the recreational facility listed below as follow:

2. The parties to this agreement agree that the amount payable by the Rural Municipality of Rosedale No. 283 shall be paid to the Town of Hanley on or before the 31<sup>st</sup> day of December in each year.
3. The Town of Hanley hereby agrees to provide to the Rural Municipality of Rosedale No. 283 such documents and accounting necessary to substantiate the amount of monies expended upon the recreational facility mentioned within this agreement. Such documentation shall be provided on or before the 31<sup>st</sup> day of January the year following the expenditure of such funds.
4. The Town of Hanley and the Rural Municipality of Rosedale No. 283 agree that the recreational facility mentioned in this agreement and supported by the amounts also mentioned in this agreement will be available for all residents of the Rural Municipality of Rosedale No. 283.
5. It is understood and agreed that this agreement shall be continuous but the agreement may be terminated by either party to the agreement giving 30 days’ notice in writing.
